1	The total number of sections of Bal Vatika shall be restricted to 03 (01 section each for Bal Vatika 1, 2 and 3 respectively). The total number of sections from classes I to XII shall be restricted to 12, of which not more than 1/3rd sections may be used for senior secondary classes. Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by e law and availability of class rooms of greater than 500 sq. ft. dimension. Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
